To this day, SRI is most frequently practiced (though not exclusively) by private, faith-based institutions rather than by public ones; for example, the 2016 NACUBO-Commonfund Study of Endowments shows that among institutions of higher education, SRI is practiced by 32 percent of private colleges and universities but just 18 percent of all public institutions and their supporting institution-related foundations (IRFs).
