The four-step process for managing classified information. Good practice says that classification should be done via the following process: This means that: (1) the information should be entered in the Inventory of Assets (control A.8.1.1 of ISO 27001), (2) it should be classified (A.8.2.1), (3) then it should be labeled (A.8.2.2), and finally (4) it should be handled in a secure way (A.8.2.3).

2) Classification. Next, you need to classify the information. Asset owners are responsible for this, but it ' s a good idea for senior management to provide guidelines based on the results of the organisation ' s ISO 27001 risk assessment. Information that would be affected by bigger risks should generally be given a higher level of confidentiality.

Contrary to what you might expect, it does not follow that the bigger and more complex your organisation, the more levels of confidentiality you will have or require.

Information classification is a key part of any ISO 27001 project. In the standard, control objective A7.2 is titled ' Information Classification ' . The objective of this control is " to ensure that information receives an appropriate level of protection " .
